2016 and 2017 Arun Infrastructure Capacity Studies for ALP

- Recognises library in Arundel, and that any new provision in the district due to growth would have to be provided using the Tier 7 offer (small selection of books and pick-up point, 'click and collect') entirely dependent on developer contributions
- Police force and infrastructure needed will need to grow along with growing population of Arun
- Identifies that in 'worst case' scenario, 1,000 dwellings per annum, there may be an impact on Arundel Fire Station in terms of infrastructure capacity (does not include proposed employment development in assessment)
- New development will require more Community First responder teams and existing services expanded. Funding for both will be required via developer contributions
- Waste Infrastructure review will look at what is required

2016 Indoor & Built Facilities Study for ALP

- Active People Survey results show that the most popular sports in the district are Cycling, Swimming then gym sessions
- Identifies no sports halls in Arundel
- Identifies Arundel Lido is available for community use and the Livingwell Health Club is not. Both are excluded from the Facilities Planning Model in the report due to being lidos, holiday park pool/leisure pools or small teacher pools based on their ability to fulfil the need of swim clubs and recreational swimmers. In most cases the pools are too small or are only available at certain times i.e. seasonal
- Identifies Livingwell Health Club as a Health & Fitness Suite but does not include it in assessment due to commercial sensitivities
- Identifies no indoor bowls facilities in Arundel but national trends show sport is declining and does not appear to be unmet demand in district

2016 Open Space Assessment for ALP


- Identifies Arun Street Garden (Quality Score of 42.6%, Value of 30%), Jubilee Gardens (56.7%, 32.7%) and Nineveh Gardens (44.6%, 30%) as formal gardens which provide accessible high-quality opportunities for informal recreation and community events. Both lower scores due to fewer ancillary facilities available including toilets, signage, picnic tables, benches and bins.
 - NOTE: Quality score of <55% considered low and >55% high. Lower scores not necessarily due to specific quality issues but also due to lack of ancillary facilities such as toilets, picnic benches etc. Value score of <20% considered low and >20% high.
- Identifies no natural and semi-natural greenspace in Arundel

- Identifies no recreation ground in Arundel but Canada Road POS (55.4&, 36.3%) and Heringtons Field (54.2%, 37.4%) as amenity greenspace which offers opportunities for informal activites close to home or work or enhancement of the appearance of residential or other areas. (see list on pages 40-43 as map identifies one other)
- Identifies Canada Road Play & Skate Area (64%, 46.2%) and Ellis Close Play Area (60.9%, 46.2%) as LEAPs (Local Equipped Area of Play. Designed for unsupervised play and a wider age range of users; often containing a wider range of equipment types.)
- Identifies Priory Road Allotments (59.5%, 41%) and Fitzalan Road Allotments (44.8%, 49.2%) as allotments. States Fitzalan Road Allotments have no specific quality issues but fewer ancillary facilities such as bins, shelter and fresh water supply.
- Identifies Arundel Cemetery (55.6%, 31.2%) and St Nicholas Church Yard (5.5%, 36.4%) as cemeteries and churchyards.
- Identifies The Square (War Memorial) (57.2%, 46.4%) as a civic space.
- Does not identify green corridor provision due to extent of provision that potentially exists, but recognises there is likely to be a variety of forms of provision (e.g. pathways, PROW, pedestrian areas, streets).

2017 School Provision in Arun Study for ALP

- Requires the provision of a new 2FE primary school in Ford
- Would like to see secondary schools operate at a minimum of 6FE and above, currently 4FE and 5FE secondary schools well
 established
- Wishes to ensure that sufficient land is available for future expansion to 10FE (total site size 10.5 ha)
- There is a need over the plan period for a new 10FE Secondary School to mitigate impact of strategic development sites proposed (none in Arundel) and site options in the Ford area should be considered
- Site Assessment shows Options C (Ford) and F below potentially suitable and should form basis for discussions
